AN ORDINANCE PROVIDING FOR THE LEVYING AND ASSESSMENT TAXES BY THE RIVER GROVE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2022 AND ENDING JUNE 30, 2023

WHEREAS, on the 14th day of September, 2022, an Ordinance entitled "ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATIONS OF THE RIVER GROVE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING "JULY 1, 2022 AND ENDING JUNE 30, 2023," was duly passed and approved and the same has been published according to law, there having been appropriated for the fiscal year beginning July 1, 2022 and ending June 30, 2023, the sum of \$1,445,443.53 for library purposes of the River Grove Public Library District.

NOW, THEREFORE, Be it Ordained by the Board of Library Trustees of the River Grove

Public Library District as follows:

Section 1: That the Board of Library Trustees of the River Grove Public

Library District, in accordance with the provisions of the statute in such case made and provided,

have duly ascertained the amount of appropriations for all corporate purposes legally made to be the amount of

ONE MILLION, FOUR HUNDRED, FORTY-FIVE THOUSAND, FOUR HUNDRED, FORTY-THREE DOLLARS and

FIFTY-THREE CENTS, (\$1,445,443.53) and do hereby determine that of that amount there shall be collected from

this tax levy for the said fiscal year beginning July 1, 2022 and ending June 30, 2023, the sum of

NINE HUNDRED, SEVENTY-FOUR THOUSAND, THREE HUNDRED, SEVENTY-SEVEN DOLLARS, and

EIGHTY-SIX CENTS, (\$974,377.86).

Section 2: That the purpose for which said appropriations and levy are made, and the sums or amounts appropriated to be collected and used for each purpose and the amounts to be raised by tax levy are hereby ascertained to be as follows:
